



I, the undersigned, have been advised of and/or recognize the risk inherent with my child's participation in this program. I assume full responsibility for all injuries that may arise from his/her physical or emotional limitations. I unconditionally release Alliance Crossroads and its employees from any and all liability or claims that may result from his/her participation in this program. This child has no health, emotional, or injury-related conditions (recent or chronic) which will be aggravated by or which will exclude his/her active participation Alliance Crossroads activities. This child has seen a physician in the last year. In case of injury or illness, I give permission for the above child to be transported to and receive medical treatment at a local medical facility, and I guarantee the payment of all expenses incurred for such transportation and treatment.

I understand that Alliance Crossroads has taken all precautions and reasonable steps to minimize all risks to participants but is unable to completely guarantee that no injury will come to my child. Since the events are mainly conducted outdoors in wilderness areas, there is always the possibility of a slip on rough ground, a fall over obstacles in darkness, or the occurrence of some other unforeseeable accident. Further, since my child may also be participating in mock battles using padded weapons, there is a risk of injury from other participants.

I understand the risks involved in my child participating in the events sponsored by Alliance Crossroads. Neither I nor my assignees shall make a claim of any description against the organization, members or officers of the Alliance Crossroads or any company doing business with the organization for any loss or damages suffered in the course of participating.

I confirm that my child is in good physical health and does not suffer from any physical disabilities unknown to Alliance Crossroads. I agree also to the following restrictions placed by Alliance Crossroads:

- Neither I nor my child will use the padded weapons approved by Alliance Crossroads unless having first been instructed in their proper use through safety training;
- Neither I nor my child will bring or consume alcoholic beverages or any illegal drug during any event;
- Neither I nor my child will use any skills taught by Alliance Crossroads for illegal purposes;
- I grant Alliance Crossroads the right to photograph, film, or videotape me and my child participating in events and to use that film or tape for purposes including, but not limited to, books, flyers, and publicity materials with no compensation of any kind owed;
- My child and I will at all times abide by the safety rules of Alliance Crossroads, and obey the safety instructions of its officers.

I understand that my or my child's failure to abide by these agreements could result in expulsion from Alliance Crossroads or in the extreme to legal action. By my signature, I confirm that I have read this release, understand its terms, and agree to its provisions. I understand that this form affects my legal rights.
